## **MESSAGE FROM LABOR RELATIONS REGARDING THE 2019 PLANT VACATION SHUTDOWN**

**NOTICE:** In accordance with provisions of Paragraph 202(b) of the 2015 UAW-GM National Agreement, be advised that Parma Metal Operations will not declare a vacation down period, for 2019. Note that this is based on the schedules of the assembly plants that we support, which indicate that a substantial portion of these facilities will be operating as normal during the weeks in July that are usually declared as Plant Vacation Shutdown Week(s).

As a result, employees making application for vacation time off will not be required to withhold any vacation entitlement hours for a shutdown week.

As a reminder, employees who desire to schedule vacation time during the calendar year should make application utilizing the HCC or through their Group Leaders during the application period which ends on February 28, 2019.
